Motorcyle wreck kills judge's son

A motorcycle accident in Lyon County three days before Christmas killed Gerald V. "Jerry" Knight Jr., 42, the son of Caldwell County Judge-Executive Van Knight. The accident occurred at 10:14 p.m., Dec. 22 on Gray Farm Road, four miles south of Eddyville, according to the Kentucky State Police. Knight was riding a 2006 Harley-Davidson motorcycle when he ran off the road and struck a tree. He was not wearing a helmet. The Lyon County coroner pronounced Knight dead at the scene.

Broadbent hams may move to Kuttawa

Broadbent B&B Food Products of Cadiz may relocate from its longtime Trigg County home to Kuttawa. Owners are considering a site next to Interstate 24 at Exit 40 behind Hucks Travel Center. The Kentucky Agriculture Development Board has approved a \$400,000 forgivable loan to help finance a new building and upgrade equipment, according to the Lyon County Herald-Ledger newspaper. Lyon County leaders, trying to lure the company to Kuttawa, are meeting this week to shore up some of the other details, including the construction of an access road to the proposed site. In the meantime, Trigg County officials are fighting to keep the business there. Ronny and Beth Drennan, who own Broadbent B&B Food Products, live in Fredonia and want to move their business closer to home, the Lyon County newspaper reported, B&B hams won the American Cured Meat Championships in 2002, 2003 and 2004 and the Grand Champion Country Ham in 2002, 2005 and 2006 at the Kentucky State Fair.

Seven die during New Year's holiday

Preliminary statistics indicate that nine people died in seven separate crashes on Kentucky's roadways during the New Year's holiday period from Friday through Monday. Preliminary data indicate alcohol was a suspected factor in one of the seven crashes. All of the crashes involved motor vehicles and seven of the nine victims were not wearing seat belts. One double fatality crash occurred in Breathitt County and one double fatality crash occurred in Woodford County. Two single fatality crashes occurred in Jefferson County. Single fatality crashes also occurred in Laurel, Pulaski and Spencer counties. During 2005-2006 New Year's holiday period, eight fatalities were reported in seven crashes. Preliminary statistics indicate that a total of 907 people lost their lives on Kentucky roadways during 2006. Of the 766 motor vehicle fatalities, 494 victims were not wearing seat belts. Of the 73 motorcycle fatalities, 48 were not wearing helmets. Of the 10 ATV fatalities, none were wearing helmets. There have been 53 pedestrian fatalities and five bicycle fatalities. In 2005, a total of 985 people lost their lives on Kentucky roadways. Citizens can contribute to highway safety by reporting erratic drivers to the Kentucky State Police toll-free at 1-800-222-5555. Harper has spent \$2.5 million in race

Republican Billy Harper of Paducah has spent nearly \$2.5 milion so far on his campaign for governor. Harper had raised a little over \$2.5 million since his campaign began, The Courier-Journal of Louisville reported. More than \$2.4 million of that has come from his own loans to the campaign, according to a report Harper filed Tuesday with the Kentucky Registry of Election Finance. Harper, who runs a western Kentucky construction company, reported \$85,755 in contributions from others. Harper is running on a slate with fellow Paducah businessman Dick Wilson. He began running television ads for the 2007 governor's race late last year in effort to increase his name recognition. Harper has said that Republican Gov. Ernie Fletcher is too politically weak to win a second term.

New coal mine will open at Sebree

A Webster County coal company has announced its plans to open an underground coal mine in Sebree. Pact Resources LLC expects operation of the new mine to begin sometime in 2009, according to a news release from Northwest Kentucky Forward, the economic development corporation based in the four-county region of Henderson, Webster, Union and McLean counties. As many as 140 jobs are anticipated at the mine, "with average annual wages exceeding \$60,000," the Providence Journal Enterprise reported. The process to obtain permits has already begun, and the company anticipates completion of the mine's construction within the next 12 to 14 months. Pact Resources LLC is based in Henderson. It currently controls, through leases, options, and outright ownership, 90 million tons of coal, the release stated.

Motel plans still on go

Lodging plans contingent on sewer line

Plans for a new 20- to 30room motel are a little more certain as the City of Marion completes engineering on a sewer expansion project on U.S. 60 East.

and Jerry Linda Holsapple, who last summer purchased S&J Barbecue at the former drive-in theater property, plan to build the motel either independently or through a franchise. The Holsapples have said the project was contingent on obtaining sewer service.

The City of Marion will expand existing sewer service from the intersection of U.S. 60 at Old Salem Road to the Holsapple's property just east of Airport Road.

Marion Mayor Mickey Alexander said the \$400,000 grant being used for the project is actually coal severance tax money that the city qualifies for because there is an active coal mine in the

Engineers' designs for the project are 75 percent complete, according to city administrator Mark Bryant. Installation of the sewer line could begin as early as this spring. Bryant said it is still undetermined whether the sewer line will operate on gravity flow or whether a lift station will be required to

complete the service.

The Holsapples say they are comparing costs of an independent operation versus a franchise and are gathering information but will not begin construction until they are certain the sewer project will be completed. The Holsapples are currently expanding S&J Barbecue, nearly doubling the size of the building, and also maintain Crittenden County's only RV park on the back of the restaurant property.

been raised. Baker said metal posts won't work in the moist, often swampy, Louisiana soil. Therefore, they are ordering 2.5-inch wooden posts from a company in Oklahoma. The posts will be shipped directly to three parishes that produce the lion's share of the state's cattle. Those areas were among the hardest hit, Baker said.

If enough money is collected, an additional load of posts may be sent south. Baker is also trying to put together a work party to travel to Louisiana to assist in building new fences.
