Student council hosts skateboard event at park

All Crittenden County High School and Middle School skateboarders are invited to show off their skateboarding skills at the first ever CCHS Skateboarding and Hacky-Sack Competition.

GOP finds toe-hold in Livingston

It's been 50 years since a Republican was magistrate

For the first time in decades, a member of the Republican party has won an election in Livingston County, predominantly controlled by Democrats.

Livingston, a highly populated "blue" county, sees most of its political competition during Democratic primary races. Candidates tend to be members of the Democratic party and Republican's and independents make little ground.

That all changed Nov. 7 with the election of Brent Ferrell to the District 3 Magistrate position repreSalem, Lola and the surrounding

area. "It's been over years," since a Republican was in office, said Charles

However, this year's District 3 magisterial race was closely contested as Ferrell ran against Democrat Larry Barnes.

"Both are super qualified," Livingston Judge-Executive Chris Lasher.

Both were political newcomers and Barnes had ousted two-term magistrate Jerry Deatherage in the pri-

In the general election, Ferrell, who was unopposed in the primary, defeated his Democratic rival by 49 votes in a race where 769 ballots were cast.

"I'm very pleased," said Ferrell, who added that his first objective after taking office in January is to orient himself to the fiscal court, county government and current projects.

"I will represent the interest of people of the Third District to the best of my ability," said Ferrell.

"The one thing I can say about these men is they ran a campaign the way a campaign should be run," said Lasher.

According to the county judge, both candidates ran a clean race and kept the campaign about "policy points."

Both can leave with their heads held high," he said. It's a new day

"I've been coming back for many, many years," said Yehling "It's really nice to be in place that is so peaceful."


