2015 CHRISTMAS PARADE GUIDELINES

December 5, 2015 / 5:00 PM

Line-up will be on West Elm Street

Theme – “A Picture Perfect Christmas”

1. Each parade entry must fill out an entry form and sign the liability release section. Deadline for all entry forms is Monday, November 23, 2015. Return application to:

2. The name of the organization must be clearly displayed on each entry.
3. Float participants are encouraged to use the parade theme, **“A Picture Perfect Christmas”**. All entries must be in keeping with the Christmas spirit.
4. In an effort to maintain safety, please use good judgment if you will be handing out candy. **NO STICK CANDY IS ALLOWED!**
5. No live Santa’s are permitted on any floats except the one provided by the Parade Committee and he will be riding at the end of the parade on the fire truck.
6. **NO ALLTERRAIN VEHICLES, UNLESS THEY ARE PULLING A FLOAT.**
7. All vehicles shall proceed at a safe and appropriate speed, shall maintain a safe driving distance from spectators and shall not weave from side to side. All drivers must be licensed.
8. All horse entries must be handled by people with crowd experience and safe for all concerned. Horse entries will be placed near the end of the parade unless they provide their own clean-up crew during the parade.
9. Judging of the floats will take place during the parade. Cash awards are sponsored by Marion Tourism.
10. Line-up is on West Elm Street at 4 PM with the parade beginning at 5 PM, Saturday, December 5, 2015.
